All other pretrial motions must be filed and heard by the Court on or before the Friday prior to trial.

ALL OBJECTIONS TO EXPERT WITNESSES AND/OR MOTIONS TO EXCLUDE EXPERT TESTIMONY – INCLUDING KELLY/DAUBERT/ROBINSON MOTIONS MUST BE SCHEDULED AND HEARD AT LEAST 10 DAYS PRIOR TO THE DATE OF TRIAL.

LAST MINUTE DESIGNATION, SUPPLEMENTATION, ETC. WILL NOT BE CAUSE FOR AN EXCEPTION TO THIS RULE.
