JOB TITLE: FACILITIES DIRECTOR for POTTER COUNTY SHERIFF'S OFFICE

#### JOB DESCRIPTION:

Oversee and maintain all operations of the Detention Center and related properties, including preventive and emergency maintenance. Direct staff, assign work duties, and ensure the safety and welfare of county-owned buildings. Manage, schedule, and prioritize multiple projects and deadlines. Manage security camera operations and programming. Administer all aspects of HVAC, boiler, commercial kitchen, and laundry equipment operations. Design, implement, and oversee all facility-related projects. Perform troubleshooting and repairs for all assigned systems and equipment. Maintain up-to-date knowledge of safety codes, regulations, and emergency operations. Manage DDC & EMS systems, as well as energy management initiatives. Handle administrative duties, including project close out documents and compliance reports. Be available for emergency callout and able to work in a correctional setting, including mandatory rotating on-call duty and holiday shifts as needed.

# **SKILLS REQUIRED:**

To perform this job successfully, individuals must possess extensive knowledge and experience in industrial and commercial maintenance, including: HVAC (Direct Digital Control, parallel rack systems, boilers, pumps), electrical, plumbing, construction, painting, electronics, and control wiring; familiarity with project management, blueprint and schematic design/reading, drafting, and all phases of construction (from conceptual design to project close out); experience with administrative duties and schedule management; thorough understanding of local, state, and federal code enforcement regulations, including UBC (Uniform Building Codes) and NFPA (National Fire Protection Administration) standards; knowledge of life safety operations and emergency response planning; proficiency with IT and security operations, including computer, phone, and network systems; familiarity with commercial kitchen and laundry equipment, chemical management systems, and hazardous emergency response equipment; ability to obtain and maintain knowledge of minimum required standards set forth by the Texas Commission on Jail Standards; ability to utilize Bluebeam Review Program for project plan reviews, daily operations, and record management, and; knowledge of preventative maintenance programs and implementation

# **EQUIPMENT USED:**

Must be able to successfully complete a Basic County Corrections Course to obtain a Texas jailer license within one year after employment (training will be provided). State licensure requirements include:

- Must not have any felony or class A misdemeanor convictions
- Must not have any class B misdemeanor convictions within the past ten (10) years preceding the date of application
