ORDER CONTINUING DISASTER DECLARATION

COUNTY OF POTTER §

WHEREAS, on May 31, 2023, the County Judge of Potter County, Texas issued a Declaration of Local State of Disaster for northern and northwestern Potter County, Texas in response to an ongoing flood emergency in that area; and

WHEREAS, the Declaration of Local State of Disaster was continued by the Commissioners Court on June 8, 2023; and

WHEREAS, the area subject to the Declaration of Local State of Disaster experienced serious flooding which has resulted in significant property loss and which presented an imminent threat of damage, injury, and loss of life and property; and

WHEREAS, the affected areas continue with recovery and rehabilitation efforts following the flooding; and

WHEREAS, during recovery and rehabilitation, additional areas of Potter County have been identified that have been impacted by the flooding; and

WHEREAS, the conditions necessitating the declaration of a local disaster continue to exist;


NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF POTTER COUNTY, TEXAS:

1. That the state of local disaster proclaimed by the County Judge of Potter County, Texas on May 31, 2023 and continued by the Commissioners Court on June 8, 2023, be, and hereby is, CONTINUED and shall remain in effect until further order of the Court.

2. The Declaration of Local State of Disaster shall be modified to include the area commonly referred to as the River Road area of Potter County.

3. The Declaration of Local State of Disaster may be modified at a future date by the Commissioners Court should additional areas in Potter County be identified that were significantly affected by the flooding.


