- 1. **APPROVAL OF MINUTES**: To recognize the minutes from the October 14, 2019 Potter County Commissioners' Court.
- 2. **BUDGET AMENDMENTS:** To consider and act upon budget amendments for the fiscal year 2019-2020.

Property Owner: Amarillo Economic Development Corporation

<u>Applicant for Tax Abatement:</u> Bovina Burger LLC, an Idaho limited liability company (real property), and SSI Foods LLC, an Idaho limited liability company (personal property)

Reinvestment Zone: No. 10 (17.10 acres in Amarillo EDC's CenterPort Business Park)

<u>Anticipated Improvements:</u> Construction of a 75,000 + square foot meat production and processing facility, and installation of meat production and processing equipment and related facilities.

Estimated Cost of the Improvements: Facility: \$19,000.000; Equipment \$23,000,000 (Total: \$42,000,000)
