1. **THERE IS A TABLE IN THE JURY ROOM TO CHECK IN.** DEFENDANTS ARE REQUIRED TO CHECK IN AS THEY ARRIVE. AFTER CHECKING IN, DEFENDANT WILL BE DIRECTED TO YOUR DESIGNATED SPACE.
2. YOU SHOULD HAVE RECEIVED AN OFFER ON EACH CASE AND MAY **HAVE WORKED CASES OUT WITH THE STATE BEFORE TODAY.** AS TO ANY UNRESOLVED CASES, MEET WITH THE PROSECUTOR ASSIGNED TO EACH CASE TO DETERMINE IF AN AGREED PLEA CAN BE ARRANGED.
3. ONCE YOU HAVE EITHER WORKED OUT A PLEA OR DETERMINED A TRIAL IS NECESSARY CONCERNING EACH DEFENDANT, APPROACH THE BENCH WITH YOUR CLIENT AND **MAKE A PLEA ANNOUNCEMENT CONCERNING EACH OF YOUR CASES.**
4. CASES WHICH ARE TO BE PLED WILL BE DIRECTED TO 181st COURTROOM WHERE THE JUDGE WILL BE CONDUCTING PLEAS.
5. CASES WHICH ARE NOT RESOLVED WILL BE PLACED ON A TRIAL DOCKET.
6. DEFENDANTS WHO DO NOT APPEAR WILL HAVE THEIR BOND FORFEITED. A FAILURE TO APPEAR AND ARREST WARRENT WILL BE ISSUED.
7. EXCEPT TO ATTEND THE PLEA HEARING, NO DEFENDANT MAY LEAVE THE PREMISES UNTIL RELEASED BY THE JUDGE.
8. FAMILY MEMBERS AND GENERAL PUBLIC MAY ATTEND THE HEARING IF A PLEA IS CONDUCTED.
